ealthcare become one of the largest economic sectors in India both in terms of revenue and employment. The overall healthcare industry in India is valued over USD 110 billion, which is expected to reach USD 372 billion by 2022. The country has the largest number and best of doctors in the world. The country targets 8 million medical tourists by 2020.

The Government of India has been proactive in boosting the Indian healthcare industry. One such step is the opening up of the sector to foreign investors with roll-out of positive foreign direct investment norms. Another step forward has been setting up of Medical Techno Parks with the purpose to reduce cost of production, as these parks will have in-house manufacturing units and facility for consolidated raw material procurement. The Indian Certification for Medical Devices (ICMED) Scheme was introduced to bring down the substantial time and cost-run to obtain globally accepted quality certification for Indian companies. India has been growing as the key market for medical devices and diagnostics due to its acquired relative strengths in manufacturing and exports leading to improvement in product quality and price control, making healthcare more accessible and more affordable.


